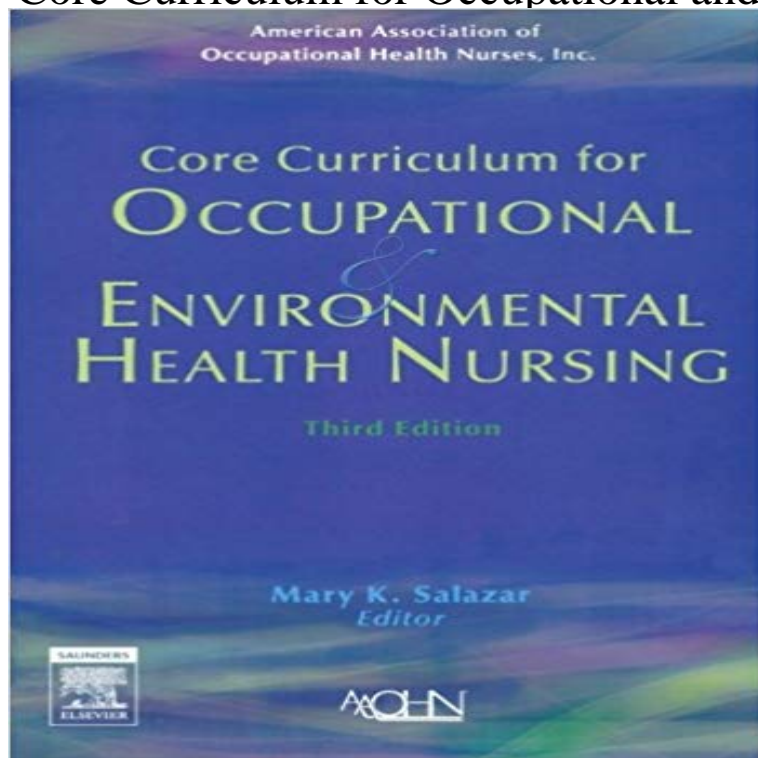


Core Curriculum for Occupational and Environmental Health Nursing, 3e
