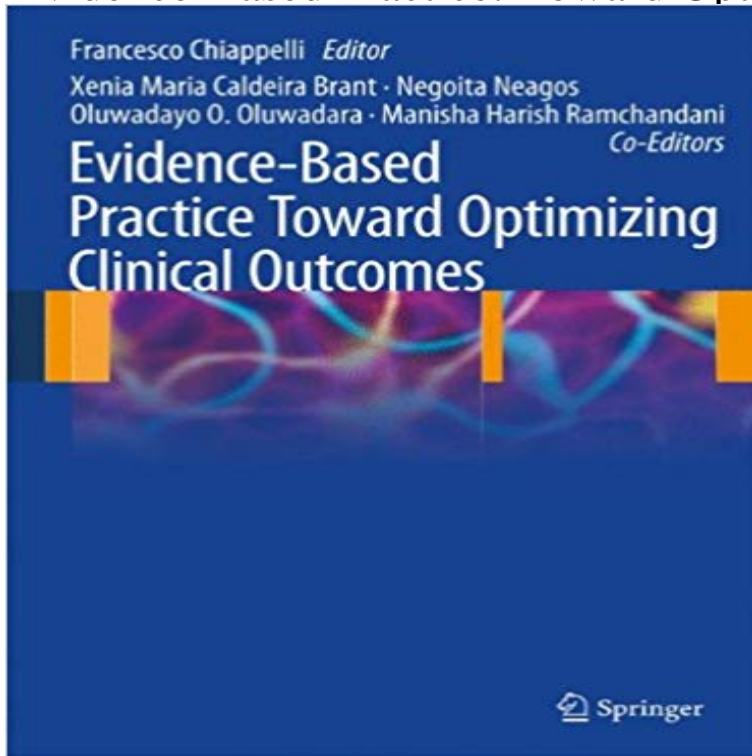


Evidence-Based Practice: Toward Optimizing Clinical Outcomes
