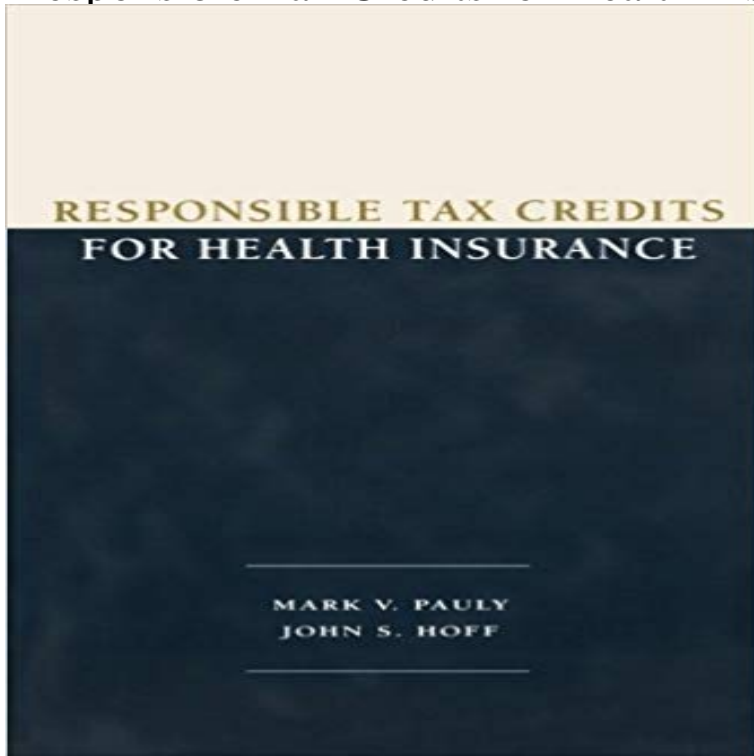

Individuals who are not required to file a federal income tax return because **Individual Mandate Penalty You Pay If You Dont Have Health Affordable Care Act Tax Provisions for Individuals and Families** A tax credit you can use to lower your monthly insurance payment (called your premium) when you enroll in a plan through the Health Insurance Marketplace. If your estimated income falls between 100% and 400% of the federal poverty level for your household size, you qualify for a premium tax credit.
