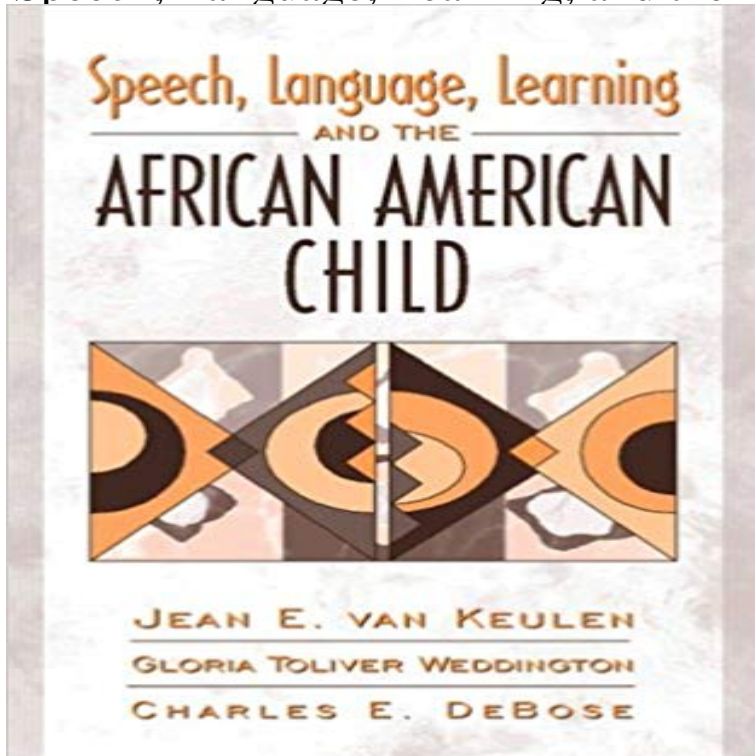


## Speech, Language, Learning, and the African American Child
