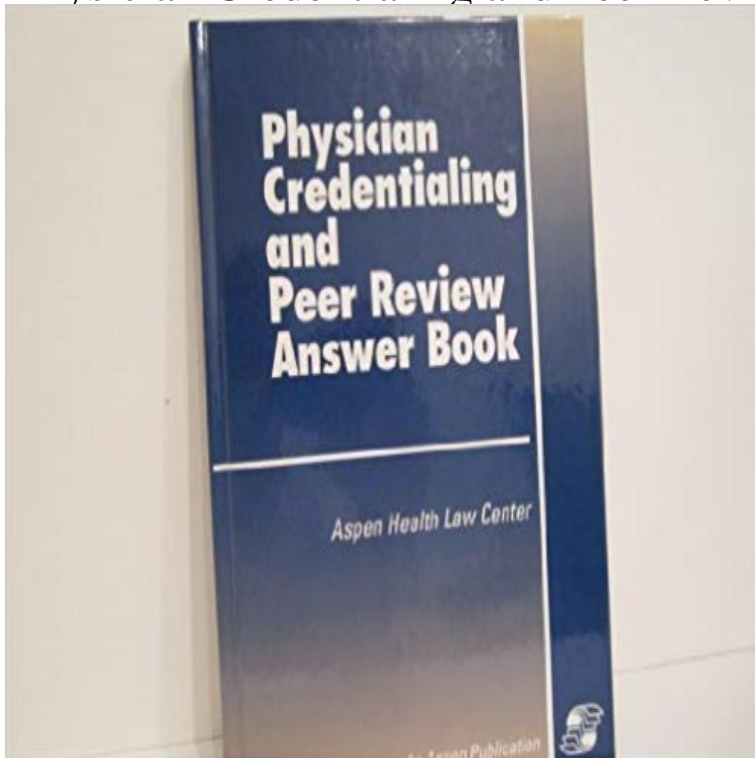


Physician Credentialing and Peer Review Answer Book
