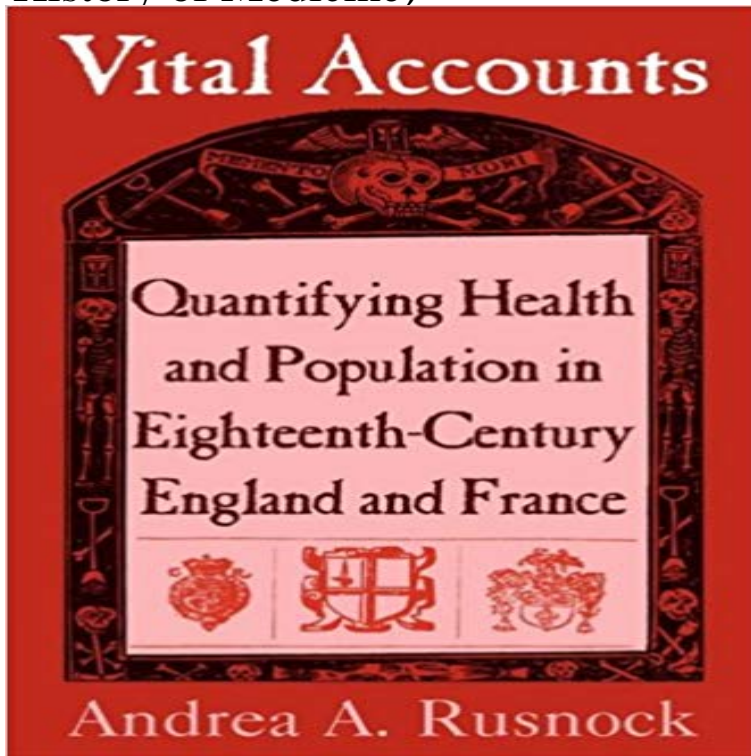


Vital Accounts: Quantifying Health and Population in Eighteenth-Century England and France (Cambridge Studies in the History of Medicine)
